### **RECOMMENDATION**

That the Active Transportation Advisory Committee (ATAC) review and approve Complete Streets Checklist for SR 29 Napa Valley Forward: Oakville Intersection Improvement Project.

### **EXECUTIVE SUMMARY**

The Complete Streets (CS) Checklist is required pursuant to Metropolitan Transportation Commission (MTC) guidelines to ensure that projects funded within the Bay Area consider the accommodation of pedestrians, cyclists, and public transit users as part of project planning, design, funding, and construction. County Transportation Agencies (CTAs) are required to review and seek approval from the designated ATAC to ensure accommodation needs are incorporated early in the project development process.

### **BACKGROUND AND DISCUSSION**

In March 2022, the Metropolitan Transportation Commission adopted a new Complete Streets Policy (MTC Resolution No. 4493). The goal of the policy is to make sure that people who are biking, walking, rolling, and taking transit are safely accommodated within the transportation network. The Complete Streets Policy requires that projects funded with regional funds implement local Complete Streets plans and implement All Ages and Abilities design guidelines on the Active Transportation Network.

This checklist is required for all projects receiving discretionary funds, including Class 1 multi-use pathways.

### SR 29/Oakville Intersection Improvement Project

NVTA is working in partnership with the Metropolitan Transportation Commission (MTC) on the Napa Forward program to improve the SR 29 and Oakville Cross Road intersection in unincorporated Napa County. The project includes constructing a compact roundabout, pedestrian crossings, and a connection to the planned St. Helena-Yountville segment of the Napa Valley Vine Trail, a Class I multi-use facility running parallel to SR 29. These proven safety and connectivity enhancements aim to relieve congestion, improve multi-modal safety, and reduce serious and fatal injuries along the corridor.

The intersection currently experiences significant safety issues due to high traffic volumes, vehicle speeds, and a lack of dedicated infrastructure for pedestrians and cyclists. These factors contribute to the project location being on the High Injury Network (HIN), which identifies corridors with a high concentration of severe and fatal collisions.

Funding for the project has come from both local and regional sources, with MTC contributing \$8 million to date. NVTA is applying for a USDOT 2025 RAISE Grant to secure the remaining \$3 million required to complete the project. As part of this grant application, NVTA requested a letter of support from MTC and submitted a Complete Streets (CS) Checklist to ensure the project aligns with regional transportation policies and priorities.

Planned improvements include a compact roundabout, pedestrian crossings, and a connection to the St. Helena-Yountville segment of the Napa Valley Vine Trail, a Class I multiuse facility running parallel to SR 29. These upgrades will improve traffic flow, reduce congestion, and create safer conditions for all users. The Metropolitan Transportation Commission (MTC) will lead the environmental, design, and construction phases, while the Napa Valley Transportation Authority (NVTA) will oversee right-of-way acquisition.

As the only continuous north-south arterial in Napa County, SR 29 is a critical corridor connecting the region to neighboring counties and serving a mix of passenger vehicles, freight trucks, transit, bicycles, and pedestrians. The intersection also experiences heavy tourism traffic year-round. Long distances between intersections encourage speeding, contributing to unsafe conditions. This project directly addresses these challenges by improving safety and accessibility for all modes of transportation.

Napa Countywide Transportation Plan (Adopted 2021): This plan outlines priorities such as relieving congestion, improving traffic safety, and enhancing active transportation infrastructure. The proposed roundabout at SR 29 and Oakville Cross Road directly supports these objectives by improving traffic flow and safety at a critical intersection.

The Napa Valley Vision Zero Plan (adopted October 2023) aims to eliminate traffic deaths and severe injuries by 2030 through safety-focused strategies. The SR 29 Napa Forward Oakville Roundabout aligns with this goal by redesigning a high-traffic intersection to reduce collision points and lower speeds. As part of the High Injury Network (HIN), this intersection is prioritized for safety improvements, making the project a key step toward achieving the plan's objectives.

This project will construct safety and connectivity enhancements at the intersection of SR 29 and Oakville Cross Road. These improvements include adding a compact roundabout, pedestrian crossings and a connection to the planned St. Helena-Yountville segment of the Napa Valley Vine Trail, a Class I multiuse facility that will run parallel to SR 29.

The SR 29 Napa Forward Oakville Intersection Improvement project addresses safety concerns at SR 29 and Oakville Cross Road, identified on the NVTA Vision Zero High Injury Network (HIN). This high-traffic area lacks safe pedestrian and cyclist infrastructure, with limited crosswalks, poor visibility, and high vehicle speeds. The project will add traffic calming, dedicated crossings, and better lighting to enhance safety and align with Vision Zero goals and eliminate severe injuries and fatalities.

The project will improve conditions for people biking and walking by incorporating dedicated pedestrian and bicycle crossings at the intersection. These features will enhance safety, reduce potential conflicts with vehicles, and effectively lower the intersection's LTS.

The Napa Valley Transportation Authority operates Vine Transit. Vine Transit Route 10 currently serves the intersection of SR 29 and Oakville Cross Road. This regional route runs from Napa Valley College to Calistoga, stopping at the Soscol Gateway Transit Center, Napa County's primary transit hub. At the Transit Center, Route 10 connects to Amtrak Thruway Bus service, local City of Napa routes, and other regional transit options, including connections to BART, Amtrak, and the Vallejo Ferry Terminal.

The Napa Forward SR 29 Oakville Project includes pedestrianfocused improvements such as dedicated crosswalks, pedestrian refuge islands, and shortened crossing distances to enhance safety and accessibility at the intersection. The roundabout design prioritizes pedestrian visibility and reduces vehicle speeds, creating a safer environment for those on foot. The design standards for these improvements will be consistent with the Caltrans Highway Design Manual, as the project is located within Caltrans' right-of-way. # **Equity**

This project will improve travel for the adjacent Equity Priority Communities located in south St. Helena and the unincorporated area near Yountville. These communities live below the federal poverty line; have significant populations who are elderly, disabled, and/or communities of color; and have a high concentration of non-English speakers.

# Jobs and Economic Development

The project will support Napa's wine and hospitality industries as they continue to recover from the widespread impacts of the COVID-19 pandemic. The project will also create direct and indirect jobs. The improvements will connect to the multipurpose path, the Napa Valley Vine Trail, which runs west of SR 29 between St. Helena and Yountville.

The Napa Valley Transportation Authority (NVTA) is working with the Metropolitan Transportation Commission (MTC) to develop multi-modal safety and operational improvements on SR 29 Up Valley in Oakville. The proposed improvement includes adding a **compact roundabout at State Route 29 and Oakville Cross Road**.

The roundabout will significantly improve safety and reduce congestion for all modes of travel and operations along the busy SR 29 corridor.

SR 29 is the only contiguous north-south route that connects Napa to the adjacent counties of Lake and Solano. It is a critical evacuation route for thousands of people during wildfires and other public safety emergencies.

NVTA will study future improvements at SR 29/Rutherford Road and SR 29/Madison Street in Yountville at a later date.
