EXECUTIVE SUMMARY

Staff have compiled the semi-annual Measure T Progress Reports submitted by each jurisdiction for the reporting period of January 1, 2025 through June 30, 2025. The report provides an overview of how Measure T sales tax revenues are being invested in local street and road projects. Table 1, presented below, provides a snapshot of Measure T projects that were completed during this reporting cycle and includes the total Measure T amount for each project.

BACKGROUND

Under the Measure T Master Agreement, each jurisdiction is required to submit semiannual progress reports summarizing the status of Measure T-funded projects. The attached reports were submitted by September 1, 2025 in compliance with the requirement and cover the reporting period of January 1 through June 30, 2025. The next reporting cycle, due March 1, 2026, will cover July 1 through December 31, 2025 and will be the first reporting period under Measure U, which took effect on July 1, 2025.

Each report includes required project details, including, approved budget, expenditures to date, remaining balance, percent complete, and completion status. Jurisdictions also track eligible revenues and expenditures to meet the 6.67% collective Equivalent Funds requirement for Class I bicycle and pedestrian facilities. Table 4 below provides a summary of these Class I projects that are in design, under construction, or completed

Under Measure U, the collective Equivalent Fund commitment increased from 6.67% to 7%. In addition to Class I facilities, Class IV separated bikeways are now eligible, expanding the range of projects jurisdictions can use to meet this requirement.
