Member Kromann broached the subject that Calistoga residents do not want to move forward with building more housing until traffic congestion is relieved. The primary sources of congestion are the two main entrances to Calistoga. The stop sign at Highway 29 and Lincoln Ave appear to be a primary cause of congestion. NVTA Executive Director, Kate Miller, stated that traffic and housing are very much interconnected and building more housing may actually relieve congestion as most traffic is caused by people coming into the area for work. At this time there are no planned improvements for the intersection in question. A study was completed regarding the feasibility of a roundabout at the intersection of Highway 29 and Lincoln. The study concluded it was not feasible.

The suggestion was given by NVTA staff that projects proposed by the City of Calistoga could be given a higher priority in the Countywide Transportation Plan.

Member Owens stated that there needs to be better warning to riders about changes to schedules, especially as they related to Route 29.

Member Nasir stated that she felt the intersections around New Tech High warranted a four way stop. NVTA staff member Schmitz stated there is a link on the City of Napa website that allows citizens to make requests regarding this matter.
